1. Company Information

- 2. 2. Significant accounting policies

(a) Basis for preparation of Financial statement

The Preparation of financial statements in Comformity with Indian GAAP, is following Historical Cost Convention and accural basis of accounting, except where otherwise stated.  - 3. Interest received on the bank balance which is treated as income of the year.
- (d) Fixed Assets

A. Tangible Assets

Fixed assets are stated at cost less Grant Received, If any. Cost comprises of the Purchase prise of acquisition cost and any attributable cost of bringing the assets to the working condition for its intended use.

B.Intangible Assets

Intangible asstes are stated at cost less Grant Received, If any.

(e) Depreciation, Amortization and Deplation

Depreciation on fixed assets is provided to the extent of depriciable amount on the Straight Line Method (SLM) based on the useful life of the assets as prescribed in Schedule III to the companies act, 2013. No Depreciation has been provided for the current year as no Fixed assets are aquired during the year

(f) Inventories

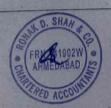
