10.1. LEAVE OF ABSENCE

The Board noted that (1) Principal Secretary, Higher and Technical Education, GoG and (2) Mr Hemant Shah were absent during the Board meeting.

10.2. APPROVAL OF MINUTES OF THE PREVIOUS BOARD MEETING
