











16.1. LEAVE OF ABSENCE

16.2. APPROVAL OF MINUTES OF THE PREVIOUS BOARD MEETING

The Board reviewed the minutes of the fifteenth meeting of the Board of GUSEC and resolved as follows:

16.4. ANY OTHER AGENDA WITH PERMISSION OF THE CHAIR

16.4.1. REGARDING DIPLOMA / DEGREE COURSES UNDER GUSEC

The Board discussed that the HPP or any other academic courses which issue the diploma or the degree by GUSEC shall henceforth be run directly by the Gujarat University. The admission, examination and teaching including the appointment of the faculty and related receipt and payments shall be transferred to Gujarat University for future administration. GUSEC shall not admit, conduct teaching or issue a diploma or degree for any academic program. However, GUSEC can issue certificates that are for participation / registration purposes for various non-academic programs.

16.4.2. REGARDING MANAGEMENT OF FUNDS UNDER GUSEC

The Board additionally deliberated and reached a decision to authorize the transfer of available funds under different budget heads of GUSEC to any section 8 company registered under Gujarat University, as and when necessary.

The Board also considered that GUSEC may undertake expenditures Jointly with Gujarat University or as per the requisition of GU, within its designated budget and in alignment to the Object of the company.

16.4.3. REGARDING AMENDMENT IN ARTICLE OF ASSOCIATION

The Board discussed and deliberated upon the Board Structure of GUSEC. Accordingly, the Board resolved the following:

“RESOLVED THAT pursuant to the provisions of section 14 of the Companies Act, 2013 (“the Act”) and any other applicable provisions of the Act and rules framed thereunder, including any modifications thereto or re-enactment thereof for the time being force, the consent of the members of the company hereby accorded for the substitution of the existing Article 41 of the Articles of Association of the company, with the amended provisions as provided here under:

The maximum term of each non-permanent member can be determined by the Board of Gujarat University Startup and Entrepreneurship Council (GUSEC).</p>	<p>The board of GUSEC shall consist of the following permanent members:</p> <ol style="list-style-type: none">1. The Hon'ble Vice- Chancellor of Gujarat University (ex-officio)2. The Registrar of Gujarat University (ex-officio)3. 
