The Board discussed and deliberated upon the Board Structure of AIC-GUSEC Foundation. Accordingly, the Board resolved the following:

**"RESOLVED THAT** pursuant to the provisions of section 14 of the Companies Act, 2013 ("the Act") and any other applicable provisions of the Act and rules framed thereunder, including any modifications thereto or re-enactment thereof for the time being force, the consent of the members of the company hereby accorded for the substitution of the existing Article 63 of the Articles of Association of the company, with the amended provisions as provided here under:




