1.2 REGARDING GU-PIER FOUNDATION BANK ACCOUNT

The Board discussed that Gujarat University is selected to establish Research Park (Park for Industrial Extension and Research - PIER). Based on the same, the Board resolved the following:

"RESOLVED THAT a Bank Account for the purpose of Park for Industrial Extension and Research of Gujarat University, be opened in the name of 'GU-PIER FOUNDATION Account'.

RESOLVED FURTHER THAT the signatures of DR HIMANSHU PANDYA and DR PANKAJ GAJJAR shall be valid to execute all such papers, documents, deeds, agreements, undertakings, declarations, acknowledgements, confirmation of all debts, securities etc. and to do all such acts, deeds and things as may be deemed necessary and expedient in this
