



**AGENDA 2.1 LEAVE OF ABSENCE:** All Directors were present in the meeting.

**2.2 MINUTES:** The Board reviewed the minutes of the first AIC-GUSEC Foundation Board meeting and approved the same.

### **2.3 REGARDING RECRUITMENT OF HEAD/CEO OF ATAL INCUBATION CENTRE OF GUJARAT UNIVERSITY**

The Board noted that as per the resolution passed in the previous meeting and due process undertaken by the competent authorities, Atal Scrutiny Committee met on 23rd August and 30th August to scrutinise the applications received for the post of Head of Atal Incubation Centre of Gujarat University. Considering the AIC-GUSEC Foundation's efficient operations and dedicated team, the Board passed the following resolution:

"RESOLVED THAT Dr Rakesh Rawal, Professor of Life Sciences Department at Gujarat University to be appointed as full-time Joint Coordinator effective immediately and take forward the necessary processes for effective implementation of Atal Incubation Center at Gujarat University.

FURTHER RESOLVED THAT the Jt. Coordinator of AIC-GUSEC Foundation, along with Director and Caretaker CEO to undertake all required processes to take the recruitment process forward."

### **2.4 REGARDING THE TRANSFER OF SHARES TO GUJARAT UNIVERSITY**

The Board discussed that as per the NITI-AIM Guidelines, Gujarat University should hold the shares of the company instead of GUSEC as it stands currently. The Board considered the same and passed the following resolution:

"RESOLVED THAT the nineteen (19) shares currently held by Gujarat University Startup and Entrepreneurship Council (GUSEC) shall be transferred to Gujarat University.

FURTHER RESOLVED THAT Dr Rakesh Rawal, Joint Coordinator and Director of the Company, be and is hereby authorized to make all such changes as may be deemed necessary, finalize and sign the same for and on behalf of the Board."

### **2.5 REGARDING UNIVERSITY CONTRIBUTION FOR AIC-GUSEC FOUNDATION**

The Board discussed that as per the guidelines of Atal Innovation Mission, NITI Aayog and as per the Gujarat University Academic Council resolution #17 dated 13th June, 2018, Gujarat University needs to transfer the amount of Rs 25,00,000/- (Rupees Twenty Five Lakhs) to AIC-GUSEC Foundation. To this effect, the Board agreed on the following:

"RESOLVED THAT the University shall be requested to transfer the University contribution to AIC-GUSEC Foundation at the earliest."
