## 11. Order for registration/approval:

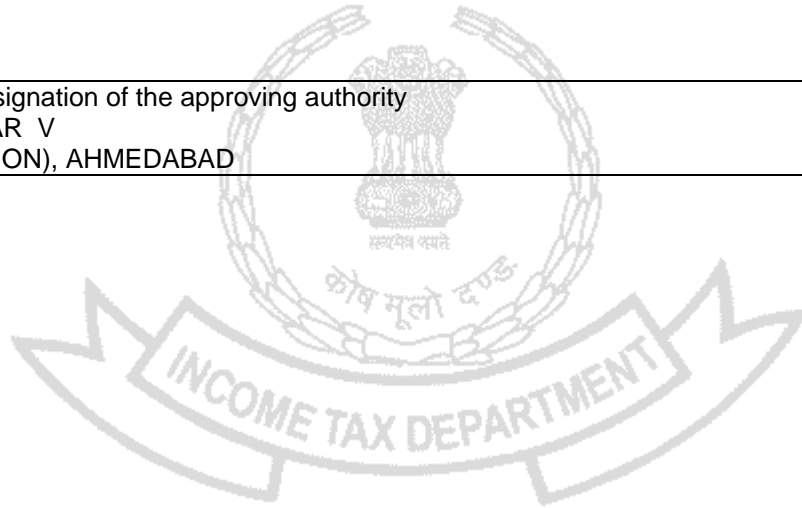

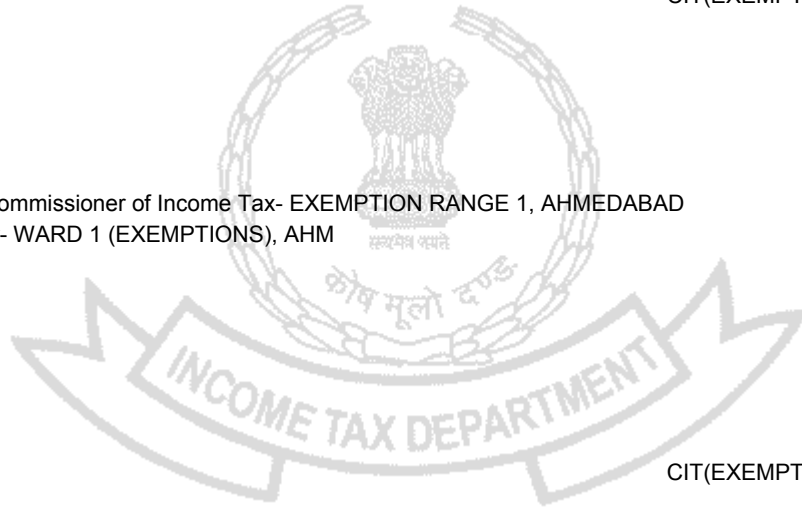
